January 21, 2021

A regular meeting of the Plymouth County Commissioners was called to order at 5:30 p.m. at the County of Plymouth Administration Building, 44 Obery Street, Plymouth, MA. Present were Commissioner Sandra M. Wright, and Commissioner Jared L. Valanzola. Chairman Gregory M. Hanley participated via Zoom.

Also, in attendance were Treasurer Thomas O'Brien, Deputy Treasurer Jeff Welch, 4-H Director Molly Vollmer, County Administrator Frank Basler, and Executive Assistant Nancy O'Rourke. Register of Deeds John Buckley participated via Zoom.

Chairman Hanley called for the Pledge of Allegiance.

Town of Plymouth BOH, Barry Potvin, Chair, concerning vaccinations and communication

Barry Potvin, Chairman of the Plymouth Board of Health participated via Zoom with a presentation of possible ideas for a mass vaccination site at the Kingston Collection Mall. Mr. Potvin questioned whether County CARES Act funds would be available to help with the regional site. Treasurer O'Brien advised funds could be available on a reimbursement basis to the individual participating towns within their individual cap limits. Mr. Potvin would like the county to assist in setting up a Zoom meeting with all Plymouth County Boards of Health and Health Agents. Chairman Hanley stated the county would be happy to assist in anyway.

Chairman Hanley would like a definitive answer from the legal team.

Legislative Focus for 2021

Treasurer O'Brien presented a draft of a legislative bill for a 20% increase in the counties portion of deeds excise receipts.
