PLYMOUTH COUNTY COMMISSIONERS <u>MEETING</u>

March 10, 2022

A regular meeting of the Plymouth County Commissioners was called to order at 9:00 a.m. at the County of Plymouth Administration Building, 44 Obery Street, Plymouth, MA. Present were Chairman Sandra M. Wright, Commissioner Gregory M. Hanley, and Commissioner Jared L. Valanzola.

Commissioner Valanzola made a motion to authorize County Attorney Resnick to retain the legal services of special counsel to assist with negotiations with Boston South Real Estate Development Group LLC. Commissioner Hanley seconded.
