Register's Report

Register Buckley reports deeds excise revenue figures due to the large amount of re-financing are approximately 1.4 million over estimates. Register Buckley would like to request any excess revenue be allocated to the un-funded liability of the Scenario 4 plan.

Register Buckley will forward language change recommendations for OPEIU union negotiations to Commissioner Valanzola and Administrator Basler.

4-H Extension Director's Report

Director Molly Vollmer briefed the board on the very successful blood drive held recently and announced a 2nd blood drive is scheduled for April 27th. Fundraising has begun for the greenhouse projects and an animal food bank has been proposed and is being developed with volunteers. Chairman Hanley gave an update on a recent meeting held with Administrator Basler and the State Plumbing Inspector regarding bathroom variances for the greenhouse.

Commissioner's New Business

Commissioner Valanzola briefed the board on a recent meeting with Kevin Tocce of WATD regarding recording Commissioner's meetings. Mr. Tocce recommended the county purchase "MeVo", a wireless live streaming camera that could be linked to Zoom and Facebook for approximately \$450.00. Commissioner Valanzola would conduct further research into the camera costs.

Commissioner Valanzola proposed a collaboration with Bridgewater State University for an internship program with the county. The interns would not be paid but would attain academic course credits depending on the job duties performed. Each department head would develop a job description for approximately 15-40 hours/week. Chairman Hanley is supportive of the proposal and cautioned against developing job descriptions for union work. Commissioner Valanzola will be responsible for all paperwork, job descriptions, and will conduct the interviews of possible candidates.

Commissioner Wright briefed the board on a recent meeting held with the Town of Middleborough Police Chief regarding the gun range. A meeting was to be held with Sheriff McDonald this past week but unfortunately had to be cancelled.

Treasurer's Report

Treasurer O'Brien gave an overview of the most recent legislation passed by the federal government that is being offered to town and county governments to administer. The American Rescue Plan Act of 2021(ARPA), unlike the CARES Act reimbursements, will have funds sent directly to each city and town to be used for vaccinations, mobile integrated health, revenue

replacement, hazard-duty pay, and investments in infrastructure costs with sewer, water and broadband. The Treasurer and board discussed the positive and negatives of the county administering the funds. The federal guidelines are ongoing and will be distributed shortly.
