Vote Transfer of Deeds Excise to Plymouth County Retirement Board for Sheriff's unfunded pension liabilities

Chairman Pallotta made a motion that pursuant to M.G.L. Chapter 64D, section 11, that certain agreement entered into pursuant to such statute by the Secretary of Administration and Finance, the actuary of the Public Employee Retirement Administration Commission, the Plymouth County Retirement Association and their actuaries, the Plymouth County Treasurer, and the County of Plymouth, the County appropriates \$3,220,158.00 from the net amount of the deeds excise remitted to the state and transferred to the Deeds Excise Fund to the County Retirement system line item to partially satisfy the state's unfunded pension liabilities for the retired employees from the Sheriff's Department for Fiscal Year 2020. Commissioner Wright seconded.

Vote to accept \$20,000 from Commonwealth of MA for Entomology Programs
