# PLYMOUTH COUNTY COMMISSIONERS MEETING

#### May 31, 2018

A regular meeting of the Plymouth County Commissioners was called to order at 5:05 p.m. at the County of Plymouth Administration Building, 44 Obery Street, Plymouth, MA. # Vote-FY 2019 Revenue

Commissioner Hanley made a motion to approve the FY 2019 Revenue Figures totaling \$10,405,292.64. Commissioner Wright seconded.

Vote: The motion passed unanimously.

#### Vote-Chapter 64D, Deeds Excise Funds-County 60%

Commissioner Wright made a motion to approve the amount of \$1,380,000.00 representing the County's 60% of the 10.625% of Deeds Excise Tax Revenue, which will be generated according to Chapter 64D, as shown in the total income figure for the operation of the County of Plymouth for fiscal year July 1, 2018 through June 30, 2019. Commissioner Hanley seconded.

Vote: The motion passed unanimously.

#### Vote-Chapter 64D, Deeds Excise Funds-Registry of Deeds-40%

Commissioner Wright made a motion to approve the amount of \$920,000.00 representing the Registry of Deeds' 40% of the 10.625% of Deeds Excise Tax Revenue, which will be generated according to Chapter 64D, as shown in the total income figure for the operation of the Plymouth County Registry of Deeds for fiscal year July 1, 2018 through June 30, 2019. Commissioner Hanley seconded.

## Vote-FY 2019 Budget

Commissioner Wright made a motion to provide for the maintenance of the County of Plymouth, its Departments, Boards and Commissions, Institutions and sundry other services, for certain improvements, and to meet certain requirements of Massachusetts General Law regulating the disbursement of County Funds and the approval thereof for fiscal year July 1, 2018 through June 30, 2019. The total for the FY 2019 Budget is \$10,405,292.64.

### Carver Stream Naming Request

Administrator Basler briefed the Commissioners on a request received from Matt O'Donnell from the U.S. Board on Geographic Names regarding a proposal to name an unnamed tributary of the Winnetuxet River in the Town of Carver. The proposal was submitted by a resident of Carver to commemorate Robert (Bob) "Grumpy" Conway (1946–2010), local conservationist, photographer, and bog foreman, and member of the Carver Conservation Commission. The Carver Board of Selectmen unanimously voted to name the stream "Grumpy's Brook". Commissioner Hanley made a motion to approve the request. Commissioner Wright seconded.

Vote: The motion passed unanimously.

## Office Products and General School/Arts & Crafts Supplies MOU with Hampshire COG

Commissioner Hanley made a motion to authorize Administrator Basler to sign an MOU on behalf of the Commissioners with the Hampshire COG to participate in a collaborative procurement for office supplies and school arts and crafts supplies for member communities within Plymouth County. Commissioner Wright seconded.

Commissioner Hanley made a motion to authorize the Chair to sign in their behalf the purchase and sale agreements for the properties at 0 Raffaele Road, Plymouth, MA from Balboni, LLC for \$335,000.00 and Lot 42-1 Long Pond Road, Plymouth, MA from Christine Silva for \$325,000.00. Commissioner Wright seconded.

## County Fire Chiefs' Donation

The Commissioners presented the County's annual contribution of \$8,000.00 for Firefighter training to Norwell Fire Chief Andrew Riordan, Onset Fire Chief Raymond Goodwin, Middleborough Fire Chief Lance Benjamino and East Bridgewater Fire Chief Timothy Harhen.
