## Addendum #1 for the Plymouth County Commissioners Vehicle Bid 2023 IFB Chevrolet Motors Posted May 19, 2023

The following changes are made to the Chevrolet PCC Vehicle Bid IFB. All remaining language in the IFB not specifically noted below remains and is part of the IFB.

## Change of Item 1, General Terms and Conditions, 1.1 deleted red crossed out language:

1.1 This Bid is for specific manufacturer's type and model of equipment as listed and requested items are grouped by section. Manufacturer's model numbers, indicating police performance vehicles as compared in contrast to civilian model vehicles, for each vehicle bid must be shown on the forms as required. Bidders must bid on ALL (each and every) of the accessories listed unless the Accessories List notes that the accessory is not a match for the manufacturer i.e., "Price for Chevrolet Bid Only" would not be bid except on the Chevrolet IFB. Bids that do not include pricing for all accessories will be deemed non-responsive and will be rejected. Plymouth County understands there may be a certification/license from Chevrolet that is necessary for the sale of medium duty trucks that precludes some dealerships from selling these vehicles. If your company is not permitted to sell a particular vehicle model or type, you are not mandated to bid on this line item. Please note that you will not be able to sell this type of vehicle if you are awarded a contract. All other vehicles should be quoted. However, if pricing for a piece of equipment, and/or accessories is not available due to manufacturer production or not available due to vehicle model, the Bidder shall indicate such reason on the forms. Under these circumstances, a Bid will not be deemed non-responsive and will not be rejected only if the Bidder provides proof and verification that the accessories are not available for the above stated reasons or, in the event such evidence cannot be produced by the Bidder, the Bidder has certified in the Bidder's Certificate for Item 1.21 that the item requested cannot be procured or offered by the Bidder for any price.

## Change of Item 1, General Terms and Conditions, 1.21 deleted red crossed out language and added red language.

All Bidders must certify that they have submitted all prices for all base vehicles, options, equipment, and accessories as directed within this RFP or have supplied sufficient evidence thereof if such Bidder did not submit a price for a field required by this Invitation for Bids, if marking NA or NM in any item of bid as stated in 1.8b. Any base vehicles, options, equipment, and accessories that do not have submitted prices will not be offered by the Bid Responder if awarded a contract through this IFB.

All vehicles on Tab One of the 2023 IFB Price Spreadsheet must have a price listed unless the vehicle is not available from the manufacturer, or you do not have authority to sell it.

Plymouth County has been informed by Chevrolet Motor Company that some vehicles will not have fleet allocation at the time of the bid response. We have also been informed that some vehicle models will lack the fleet concessions that are historically provided. In the case that either of these examples apply, please provide a price at the time of bid and you will have the opportunity to adjust the price down when the fleet concession is offered from the manufacturer. In the case of delayed allocation, please provide a statement supplied by the manufacturer regarding the timeline of availability, if provided. For vehicles not available to certain dealerships, please refer to item 1.1 above.

## The Bidder's Certificate for Item 1.21

The Bidder's Certificate for Item 1.21 is no longer a mandatory item and does not need to be signed as part of the submission package.
