The following changes are made to all PCC Vehicle Bids. All remaining language in the IFB's not specifically noted below remains and is part of the IFB.

Change of Deadline for Bid Submission: Given the unprecedented times concerning the pressures on materials, supply chains, product increases, Plymouth County will extend the following dates of all 2023 Vehicle Bid IFBs. All Bids must be submitted in a sealed envelope on or before 2:00 p.m. on Wednesday, September 14, 2022, at the Plymouth County Commissioners' Office, 44 Obery Street, Plymouth, MA 02360. No Bids shall be accepted or opened which arrive after this date and time for any reason. The Plymouth County Commissioners will open all Bids at 2:00 p.m. on September 14, 2022, in their Office on 44 Obery Street, Plymouth, MA, at which time and place bids may be examined by the public.

Change in deadline for Questions: Direct all inquiries to Frank Basler *via* e-mail at <u>FBasler@PlymouthCountyMA.gov</u>. No inquiries will be accepted after 4:00 p.m. Wednesday 31, 2022.

Cancellation of the IFB Chevrolet 2023 to 2026: due to model year 2023 ordering timelines and lack of availability of vehicles from the manufacturer, the Plymouth County Commissioners is cancelling the posted IFB Chevrolet 2023 to 2026 Vehicle Bid. This bid will be reissued in early 2023 for model year 2024 vehicles in line with Chevrolet guidelines.

All vehicles on Tab One of the 2023 IFB Price Spreadsheet must have a price listed unless the vehicle is not available from the manufacturer: Plymouth County has been informed from several vehicle manufacturers that some vehicles will not have fleet allocation at the time of the bid response. We have also been informed that some vehicle models will lack the fleet concessions that are historically provided. In the case that either of these examples apply, please provide a price at the time of bid and you will have the opportunity to adjust the price when the fleet concession is offered from the manufacturer. In the case of delayed allocation, please provide a statement supplied by the manufacturer regarding the timeline of availability if provided.

All 2023 IFB Price Spreadsheets have been modified: New 2023 IFB Price Spreadsheets will be emailed to all requesters. The new spreadsheets labelled as Addendum 1 is the price sheet that MUST be submitted with the bidder's package.

Change in Item 3 Price, 3.1: Due to historically unusual supply chain shortages and price fluctuations, Vendors are allowed to petition the Plymouth County Commissioners for price changes in vehicles, accessories, and equipment as market forces dictate. These price changes must by supported by documentation from the manufacturers and or suppliers and be presented to the Commissioners. Plymouth County Commissioners do not guarantee that price adjustments will be approved but will be investigated on a case by case basis.

Ford and Dodge 2023 IFB Price Spreadsheets vehicle list on Tab 1 have been modified: the Ford 2023 IFB Price Spreadsheet has 8 vehicles added on lines 518 through 525. The Dodge 2023 IFB Price Spreadsheet has 1 vehicle added on line 265. Dodge has added:

Change of requirement to price and sell every item on Tab 2 of the 2023 IFB Price Spreadshoots: All line items in "Tab 2 Acc & Equipment Pricing" do not need to be re-

Spreadsheets: All line items in "Tab 2 Acc & Equipment Pricing" do not need to be priced or sold by the Bidders. Bidders should ONLY price items that they intend to sell to the PCC procurement list of Bid Participants. Any items that Bidders do not price will not be considered as part of the procurement, except if the item can be covered under the "Tab 3 Accessory Vendor List" percentage discount off a catalogue price. N/A and N/M are no longer necessary. All blank cells will be considered as an item the bidder chooses not to offer.

Change of Item 1 General Terms and Conditions, 1.4: Tab 2 Accessories and Equipment, on the 2023 IFB Price Spreadsheets will not be included in the calculation to determine Total Price. The calculation to determine Total Price will include only the Total Vehicle Cost (from Tab 1) and the MSRP Discount calculation for all dealer options (from Tab 1). The Total Price of Bid (near the top of Tab One will automatically calculate). Prices listed on Tab 2 Acc and Equipment Pricing CANNOT exceed manufacturer's suggested retail price plus the appropriate install labor. The Plymouth County Commissioners reserve the right to red line any Bidder pricing of an item on Tab 2 that they feel is not appropriate to be included in the Procurement. A Contract will be awarded to one or more responsive, responsible Bidders based on the Total Price Bid.

Change to Item 6 Delivery, 6.3: If a Vendor can document that the delivery of a purchased vehicle to the buyer is caused by unusual market conditions as documented by the Manufacturer, then the Vendor will not be subject to any penalties as noted for the delay. If a purchaser decides to not honor the purchase agreement due to delays in delivery, then the Buyer will be subject to a 2% restocking fee to the Vendor.
