FIRST AMENDMENT TO

CONTRACT for DODGE CHRYSLER JEEP MOTOR COMPANY PUBLIC VEHICLES & EQUIPMENT BID PCC 2023 TO 2026 TO CENTRAL CHRYSLER DODGE JEEP RAM OF RAYNHAM, INC.

THIS FIRST AMENDMENT TO THE CONTRACT for Dodge/Chrysler/Jeep Motor Vehicles & Equipment between the County of Plymouth and Central Chrysler Dodge Jeep Ram of Raynham, Inc., 191 New State Highway, Raynham, MA 02767 ("First Amendment"), is made effective as of the date on which it is signed below by the parties hereto (the "Effective Date"), by and through the Plymouth County Commissioners, with an address of 44 Obery Street, Plymouth, Massachusetts 02360 and, with reference to the following facts:

WHEREFORE: The Plymouth County Commissioners (hereinafter "Plymouth County Commissioners" or the "County") and various political subdivisions listed on the attached Cooperative Bid List, with any amendments attached thereto, (hereinafter referred to, each individually, as the "Buyer"), and as authorized by Massachusetts General Laws, Chapter 7, Section 22B, and Chapter 30B, awarded a Vehicle Bid to Central Chrysler Dodge Jeep Ram of Raynham, Inc. (hereinafter "Contractor"). This Contract is for the then current model year Motor Vehicles and Trucks manufactured by Dodge/Chrysler/Jeep Motor Co. This Contract also provides for equipment, options, and accessories available for purchase by the Buyers under the prices stated in the Contractor's Response to the Plymouth County Commissioners' Invitation for Bids (hereinafter "Response"), subject to any increase as described by this Contract.

WHEREFORE: The Term of this First Amendment to the Contract shall be for the term starting **November 1, 2023, and ending October 31, 2024**, with the possibility of three (3), one (1) year contract extensions subject to the sole discretion and option of the Plymouth County Commissioners. The Plymouth County Commissioners shall inform the Contractor in writing within thirty (30) calendar days of its intent to extend the Contract.

WHEREFORE: The Parties acknowledge a mutual desire to Amend the Contract under the terms and conditions specified herein.

NOW, THEREFORE, in consideration of the of the mutual covenants and agreements set forth herein and in the First Amendment to the Contract, The County and Contractor, each intending to be legally bound hereby, agree to confirm certain terms, and amend the Contract.

<u>Terms</u>; <u>Definitions</u>. All defined terms used in this First Amendment and not defined herein shall have the meanings set forth in the Contract.

<u>Inconsistencies</u>. In the event of any inconsistency or discrepancy between the Contract and this First Amendment, the First Amendment shall control.

<u>Ratification</u>. Except as amended by this First Amendment, the Parties agree that the Contract remains in full force and effect and is hereby ratified and confirmed.

<u>Counterparts</u>. This First Amendment may be signed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
